Message From the Sub-Dean

Greetings, fellow AGO members! I wanted to take the opportunity to thank you for electing me as your Sub -Dean for the 2020-2021 term. I'm truly honored and humbled by your support. This brief message contains some news in the programming area of our chapter as well as some information on the projects being worked on by our Diamond Anniversary Committee and myself. First and foremost, it was decided during our May anniversary committee meeting that the celebration of our chapter's 75th Anniversary would be postponed from the 2020-2021 program year to the 2021-2022 program year. This decision was not made light-heartedly, but rather after thoughtful discernment and discussion by the committee. for liturgies. It examines the historical context and original purpose for said literature and instructs practical use for it within the Revised Common Lectionary. I look forward to sharing it with you all upon its completion in August.

RRVAGO Chapter Portative Organ is Restored

For many chapter members, our chapter's portative organ has been but a faint memory. Still somewhat of a I newcomer to the chapter, I was only vaguely aware of the instrument until recently, and through my involvement with the anniversary committee, I decided to investigate what sounded to me like a real treasure to the chapter.

With the help of chapter members and old issues of the *Pipeline*, here is what I was able to discover about the instrument's origins. It was built through grant money by the Johnson Organ Company, Inc. of Moorhead (then of Fargo) in 1989. Throughout the years, it was used by the chapter as a demonstration instrument at various events, and it has been particularly useful in educating children of the sound and construction of the pipe organ.

Found on the instrument are 40 pipes (previously 35) and one manual, consisting of $2\frac{1}{2}$ octaves of an 8' Principal rank, and one demonstration note (middle C) for each of the following ranks: Krummhorn, Oboe, Trumpet, Gedackt, Gemshorn, Salicional, and Mixture IV (4 pipes). The Salicional and Gemshorn are also ^{II} tuned so they sound as a celeste when played together so as to demonstrate the celeste phenomenon.

At some point, the portative organ fell into disuse and it was most recently stored at First Presbyterian Church of Fargo until July, 2015 when Lance Johnson brought it to his shop in Moorhead. It rested there until II this spring, when it was decided to pursue grant money which would be used to make the necessary repairs to the instrument.


A grant application was filled out and submitted, and grant money in the amount of \$1,620.90 was awarded to our chapter from the Orlee Howell Pipe Organ Fund at the F-M Area Foundation in Fargo.

Lance Johnson, President and Treasurer of the Johnson Organ Company firm, built the missing bottom five notes of the 2½-octave Principal 8' on the portative organ, constructing them out of wood and voicing them to match the metal pipes which make up the rest of the rank. A plaque was made which will be affixed to the instrument, which indicates the years of construction, builder, and owner of the instrument.

One of our newest chapter members, Mark Frisco, has generously offered to store the instrument at his church, Dilworth Presbyterian Church in Dilworth, to where it has now been moved. I look forward to seeing the chapter utilize this asset once again, and it will be especially useful to display and demonstrate as part of our upcoming 75th anniversary activities. Alex Swanson Ш

ALEX SWANSON, Treasurer. Greetings to you all, and for those of you who don't know me, allow me to tell you a bit about myself.



I was raised on a fifth-generation family farm north of Moorhead, MN in the Oak Mound Community near Kragnes. I attended the Oak Mound Congregational Church as a child and began playing for Sunday School around age 7 while still a Sunday School student. This included occasionally accompanying congregational hymns at Christmas and Children's Day programs.

My maternal grandmother, a lifelong church organist, gave me my first few organ lessons when I was 10 and it was then I began playing for parts of church services, playing for my first full service when I was 12. I was fortunate enough

I had always been fascinated by the Mighty Wurlitzer theatre pipe organ at the Fargo Theatre, and joined the Red River Theatre Organ Society (RRTOS) at age 16, serving as a house organist from 2012-16. What little training I have in theatre organ has come from lessons with Lance Johnson and Tyler Engberg, consulting with friends, and watching many YouTube videos.

Aside from music, my other biggest hobby is collecting and restoring old tractors and farm equipment, mostly two-cylinder John Deeres and a few Minneapolis-Molines. For those of you who know that I own about a half dozen organs (both reed and electronic), you would probably be more baffled to know that I also own ten tractors!

The meeting was called to order by Chairman Dillon Swanson at 3:13 p.m.

Michael Olson moved to accept the secretary's report as printed in the *Pipeline*, seconded by Ryan Hardy; motion carried.

Committee Reports:

History & Archives: Jean Hellner will seek permission to gain access to the MSUM archives so the proper materials may be accessed to begin writing the history book. Alex Swanson is writing letters to former members asking them for memorabilia and stories they could contribute to the archives and history book project. An article asking for chapter memorabilia was published in the Pipeline.

Alex mentioned that the History & Archives Committee would like to dedicate the history book to Ruth Berge, a charter member and several-term chapter Dean, Sub-Dean, and overall long-time supporting member.

Programming & Advertising: Dillon Swanson reported on the hymn festival, as he has drafted a bulletin for the event. He suggested that the festival have a theme centering around our chapter's history, what our current mission is, and where we'd like to be in the future as an organization.

Jean mentioned that a string ensemble could be put together if needed during the program year.

Dillon asked for people to respond to the bulletin rough draft he sent out earlier, including which hymn they would like to play, and any other suggestions they might have.

Dillon has talked to Scott Mehlhaff at Holy Rosary Catholic Church in Detroit Lakes and he has confirmed the date for our French organ music recital.

Old Business:

The Hymn Festival location was discussed. St. Joseph Church holds a weekly Saturday Evening Mass which would likely constrain the festival schedule. Dillon has checked with Trinity Lutheran Church in Moorhead ^{II} and they have approved of the date, though they are not officially scheduling that far ahead yet due to the pandemic.

Alex Swanson moved to change the hymn festival location to Trinity Lutheran Church in Moorhead, and to hold Rebecca Groom te Velde's workshop at St. Joseph Catholic Church in Moorhead, also changing the organ crawl date to match Rebecca's workshop date. This was seconded by Ryan Hardy; motion carried.

New Business:

Alex and Dillon have created a new Facebook page for the chapter (@RRVAGO) and it is already approaching 180 likes after a mere few days of existence. Eventually we may ask the national AGO if they could help us get the old Facebook page removed, as we have completely lost access to it.

Jean asked if we could get a website for our chapter. This was well-received and Alex mentioned that user domain www.rrrvago.org is available. It was decided that Jean and Alex will look into creating the chapter website, using the address rrvago.org. Ryan Hardy will be consulted for advice. He has suggested going ^{II} through Wix and not using Weebly.

Alex mentioned that we have a new member, Chris Strombley, who has transferred to our chapter from the Twin Cities Chapter. A welcome letter has been sent to him. (continued on Page 7)

The newly elected 2020-22 National Council will look very different from the 2018-20 Council, as a majority of the members will be serving their first terms in positions they have never previously held. Only two of the eight nationally elected members of the 2018-20 AGO National Council were eligible to be renominated. AGO President Michael Bedford, reelected to serve a third term, is the only incumbent returning to the same office.

The AGO membership overwhelmingly approved a bylaws amendment to appoint an AGOYO member to the National Council as Councillor for Young Organists, increasing the number of voting members on Council to nine. Jillian Gardner who served as a nonvoting AGOYO representative to both the NC and the BRC this past term, was elected to the new position and will now serve with both voice and vote.

Total vote counts and election statistics will be published in the July issue of *The American Organist*.
